Lunch and Learn Training Terms and Conditions

4 Paws Community Center cannot make any guarantee regarding the outcome of any training program. The owner assumes full and complete responsibility for the dog's behavior during and after the training program.

The trainer is responsible for training the dog for initial response to the commands. The trainer is responsible for training the owner to train the dog on the commands. The owner understands that they are being trained to train their dog and that without 100 % cooperation, as well as consistent reinforcement the dog will not get trained. The owner is ultimately responsible for the dog's final outcome

CANCELLATIONS: The owner of the dog may postpone any of the lessons provided 24 hour notice is given to 4 Paws Community Center. 4 Paws Community Center is only obligated to give two (2) free makeup lessons due to owner postponements. Cancellation of class less than 24 hours before the scheduled session will result in forfeiture of payment for that scheduled session.

TERMINATION OF TRAINING: the owner of the dog may have the animal withdrawn from training at any time, however, once training has begun, all fees are non-refundable

LIABILITY: I understand that participation in any dog behavior training class or lesson is not without risk to all persons or animals who may attend including, without limitation, the risk of animal bites and other injuries or illnesses resulting from exposure to animals which may be inherently aggressive or difficult to control even when handled with the greatest care. I further agree that I will comply with all instructions, rules, and decisions of the instructors of 4 Paws Community Center as it relates to me or my dog's ability to safely complete any lesson.

On behalf of myself, my pet, and any persons accompanying me at any class, workshop, or private lesson offered by the instructor, I hereby waive all claims for damage and release and forever discharge 4 Paws Community Center, it's instructors, assistants, volunteers, and representatives from any and all claims damages, losses, or liabilities of any nature, whether known or unknown, for injury or damage which I, my dog, or my guests may suffer in connection with my attendance or participation in any training lesson or my presence at any location including, without limitation, any injury or damage resulting from the action of any dog. I expressly assume the risk of such damage or injury when attending any training lesson or other function while on the training grounds or the surrounding area thereto, even though the liability may arise out of negligence or carelessness on the part of individuals or entities released in this agreement.

In consideration of and as an inducement to the acceptance of my application for participation in training lessons provided by the instructor, I hereby agree to indemnify and hold harmless 4 Paws Community Center, it's instructors, assistants, volunteers, and representatives from any and all claims, including claims of negligence, personal injury or damage by any person arising out of (1) my participation in any workshop, lesson, event, or other function, (2) the presence at or participation by any member of my family or any person accompanying me to any training session or other function, and (3) any action by any dog, including my own.

MISCELLANEOUS: The owner will be responsible for purchasing all necessary equipment that the trainer recommends for training the dog

In the event that 4 Paws Community Center deems it necessary to employ legal counsel to protect its rights under this agreement, the owner of the dog agrees to pay all expenses incurred by 4 Paws Community Center to enforce its rights under this agreement including, but not limited to, costs and reasonable attorney fees.

This training agreement represents the full and only agreement between the parties. The terms and conditions set forth in this agreement cannot be modified or changed in any way. Any alterations or addendums to this agreement will not be valid or binding, nor will they affect the validity of any non-altered portions of this agreement unless signed by both parties. I have read, fully understand, and agree to the above contract terms.
